Eligibility Criteria

Bachelor's Degree

First Year Bachelor of Pharmacy:

1. The candidate should be an Indian National and should have passed Higher Secondary school certificate (10+2) Examination of Maharashtra State Board of Secondary and Higher Secondary Education or its equivalent examination with subject English, Physics, Chemistry and Biology or Mathematics and secured minimum 45% marks i.e. 135 marks out of 300 marks (40 % marks i.e. 120 marks out of 300 marks for Backward class category candidates belonging to Maharashtra state only) in the subjects Physics, Chemistry and Biology / Mathematics (Maximum marks obtained in Biology or Mathematics shall be considered for purpose of addition).

AND

Obtained Non-zero score at MHT – CET of relevant year Entrance Examination conducted by Government of Maharashtra OR Private Management Association of Pharmacy Colleges which is authorized by PNS and Govt. of Maharashtra, India.

OR

(b) Diploma in Pharmacy with minimum 45 % marks. (The candidate should be passed from the PCI, (Delhi) approved Diploma in Pharmacy from the state of Maharashtra or other states of India.)

OR

(c) Candidates of foreign National / PIO / Children ward of Indian workers in the Gulf Countries Should have passed an examination equivalent to HSC of Maharashtra state board of secondary and Higher Secondary education with subject English, Physics, Chemistry and Bilogoy /



Mathematics secured minimum 50 % marks in the subject Physics, Chemistry and biology / Mathematics added together at one & the same seating (Maximum marks obtained in the biology or Mathematics shall be considered for purpose of addition).

OR

(d) Any other Eligibility criteria prescribed by Government of Maharashtra / Pravesh Niyantaran samittee, M.S. Mumbai.

Direct Second Year Bachelor of Pharmacy:

The Candidate must be an Indian National and should have passed Post-SSC or Post-HSC Diploma Course in Pharmacy with at least 50 % marks (45 % marks in case of candidates of Backward class categories and Physically Handicapped belonging only to Maharashtra State) from an AICTE approved Institution with English as the medium of instruction at Diploma level.

Master's Degree:

First Semester of Master of Pharmacy:

The candidate should have passed the Bachelor of Pharmacy with minimum 55 % marks from any recognized University or an Institution affiliated to any University recognized by university grants commission (UGC) and should have a valid GPAT and MHT – CET score.

OR

Any other eligibility criteria prescribed by Government of Maharashtra / Pravesh Niyantaran samittee, M.S., Mumbai.



Admission Procedure

The Institute has an intake capacity of 60 seats. The Admission Procedure were fulfilled according to the State CET Cell, Admission Regulating Authority, Director of Technical Education, Mumbai.

Eligibility criteria for Maharashtra state candidate and outside Maharashtra state candidate for admission to first year of degree course in pharmacy (as per State CET Cell, Admission Regulating Authority, Director of Technical Education).

Candidate should have passed the HSC (Std. XII) examination of Maharashtra State Board of Secondary and Higher Secondary Education or its equivalent examination with subjects English, Physics, Chemistry and Biology / Mathematics AND secured minimum 50% marks i.e. not less than 150 marks out of 300 marks (minimum 45% marks i.e. not less than 135 marks out of 300 marks in case of candidates of Backward class categories and Person with Disability belonging only to Maharashtra State) in the subjects Physics, Chemistry and Biology/Mathematics added together (Maximum of marks obtained in Biology / Mathematics shall be considered for the purpose of addition) AND Obtained a Non zero score at MH-CET OR NEET.

OR

Must have passed Diploma in Pharmacy or its equivalent examination with not less than 50% of marks in the aggregate of all subjects taken together at the Final Year Examination in single attempt and medium of Instruction as English from AICTE approved Pharmacy.

Number of seats allotted to CET (State conducted test)

The details of No. of seats of B. Pharm. allotted to different test qualified candidates are as follows:

- i) MH-CET through Govt. Centralized Admission – 48 (80%)
- ii) MH-CET/HSC result through Management – 12 (20%)



General Admission Guidelines for B. Pharm. & M. Pharm.

1. In the State of Maharashtra, all admissions are done through Centralized Admission Procedure on the basis of MHT-CET/NEET score which is conducted by Government of Maharashtra, State Common Entrance Test Cell, Mumbai.
2. The centralized admissions are done by Government of Maharashtra, State Common Entrance Test Cell, Mumbai, having website cetcell.mahacet.org.
3. The Competent Authority conducts Maharashtra State Common Entrance Test (MHT-CET) for the candidates.
4. Every student (Maharashtra State / OMS / All India Level Candidates) seeking admission to B. Pharm course must have appeared for MHT-CET/ NEET.
5. The MHT-CET 2023 brochure has been published and is available on the website cetcell.mahacet.org.
6. The eligible students have to register at Facilitation Center (FC) allotted by the competent authority and get the original documents verified and have to submit the Xerox copies of documents at FC.
7. The inter-se-merit list is published on the website by competent authority on the basis of MHT-CET score.
8. All types of candidates seeking admissions to B. Pharm under CAP must register and get documents verified at designated FC including Institute Level admissions.
9. Students have to fill the Options online or at FC through their login.
10. The provisional allotment of CAP is displayed on website as per the schedule published.
11. The competent Authority conducts the specified admission rounds.
12. The candidates report to allotted Institute and confirm the admission along with original documents and fees.



13. For admission to M. Pharm course, student must have appeared for the GPAT 2023.
14. The merit list for M. Pharm is prepared on the basis of GPAT score.
15. Admissions of M. Pharm are done by Competent Authority through online CAP rounds.
16. The Direct S. Y. B. Pharm. admissions are also made by (CAP) as above.

Rules for admissions through Institutional Quota and Vacant Seats After CAP

1. Institution will invite applications by notifying schedule of admission and the number of vacant seats in each course to be filled by the institution, by publishing advertisement on the website of the Institution.
2. Aspiring Candidates fulfilling the eligibility criteria as notified by the Government and specified by the appropriate authority, from time to time, shall be applicable to the institute for admission through the Institution Level Quota and Vacant Seats, if any, after CAP.
3. The application form for such admission will be available in the office of the institute and on Institute website.
4. The institution, after verification of all required documents, will prepare and display the Inter-Se-merit lists of the Candidates to be filled through the Institution Level Quota along with the vacant seats after CAP, on the college notice board and will publish the same on the website of the institution.
5. If any seat in CAP remains or becomes vacant after the CAP Rounds, then the same will be filled with the Candidate from the same Category for which it was earmarked during the CAP. Further, if the seats remain vacant then the seats shall be filled on the basis of Inter-Se-Merit of the applicants.
6. While filling these seats, the preference will be given to the candidates from Maharashtra State Candidature over the candidates from All India Candidature, on the basis of Inter-Se-Merit.
7. Changes if any, made in above rules, on time-to-time basis, by Govt. Authority shall be applicable.
